DESCRIPTION:

PRINTING: Prints line matter in black. The GPO imprint line must not appear on the finished product.

CONSTRUCTION: Coat the entire back of each label with a permanent type, pressure sensitive adhesive. Die-cut labels with round corners, do not penetrate backing sheet, and remove waste. Mount centered on a suitable 3-3/4 or 4" wide continuous backing sheet with 1/16" space between labels. Perforate backing sheet along the entire 3-3/4 or 4" dimension every 1" between labels.

MATERIAL FURNISHED: Contractor to pickup at GPO. One piece of same size camera copy. One sample from a previous production for use as a construction guide.

PAPER: * Must be in accordance with JCP Paper Specification Standards in effect on date of this order White Uncoated Label Paper, (basis size 25 x 38", basis weight 60 lbs. per 500 sheets).

COLOR OF INK:

Black laser printer compatible ink.

PRINT PAGE: One Side Only

MARGINS:

Follow camera copy; adequate gripper head only.

PACKING:

Fanfold suitable. Pack suitably in shipping container(s).
